

Privacy Notice – TITAN

Published on November 29, 2019

At TITAN Containers A/S ("TITAN"/"we"/"us"/"our") data protection and confidentiality is a high priority. This privacy notice sets out guidelines for TITAN's processing of customers' and suppliers' personal data and provides you with the information you have the right to receive according to applicable data protection law. You must read the privacy notice before submitting your personal data to TITAN.

1. Data controller and contact information

2. Types of personal data

The categories of personal data we collect may include:

- Your name
- Your email address
- Your phone number
- Your address
- Date of birth
- Correspondences with you
- Correspondences with you

Your personal data is collected in one or more of the following cases:

- Inquiries to us via email, telephone or regular post
- When applying for an offer

3. Use of personal data

The personal data may be collected and used for the following purposes:

- To enter into a contract with you
- To register you as a customer
- Compliance with requirements according to applicable law
- For the establishment, exercise or defence of legal claims
- Invoicing and other payment collection

4. Basis for processing your personal data

Our legal bases for the processing of your personal data for the above purposes are:

- Fulfilment of contract in connection with purchase of products or services (the GDPR art. 6 (1) (b))
- Our legal obligations as data controller (the GDPR art. 6 (1) (c))
- Legitimate interest in being able to send out service messages and to communicate with you (the GDPR art. 6 (1) (f)).



- Legitimate interest in being able to establish, exercise or defence legal claims (the GDPR art. 6 (1) (f))

5. Disclosure to other data controllers and transfer to data processors

To fulfil the above purposes, we may provide access to your personal data for third parties who, on the basis of a contractual relationship with TITAN, provide relevant services, e.g. IT-providers. Such service providers will only process personal data in accordance with our instructions pursuant to the data processor agreements entered into.

Aside from above, it is a general rule that your personal data is not disclosed to a third party without your consent. However, under certain circumstances and in accordance with applicable law, we may need to disclose your personal data to police, lawyers, courts, public authorities, prospective buyers, and affiliated companies.

Your personal data is not transferred to data controllers or data processors located outside the EU/EEA.

6. Deletion of personal data

We will delete your personal data when we no longer need to process them in relation to one or more of the purposes set out above. Personal data is in general stored in 3 years from termination of business relationship. However, the data may be processed and stored for a longer period in anonymised form.

7. Cookies

8. Security

We have implemented security measures to ensure that our internal procedures meet the established security standards and applicable legal requirements. We strive to protect the quality and the integrity of your personal data. We have internal rules on information security that contains instructions and measures to protect your data from being destroyed, lost or altered, against unauthorised disclosure, and unauthorised access to and knowledge of them.

9. Your rights

- You have the right to access the personal data we process concerning you.
- You have the right to object to our collection and further processing of your personal data.
- You have the right to have your personal data rectified and deleted, with certain statutory exceptions.
- You have the right to request us to restrict the processing of your personal data.
- Under certain circumstances you may also request to receive a copy of your personal data as well as the transmission of your personal data to another data controller (data portability).
